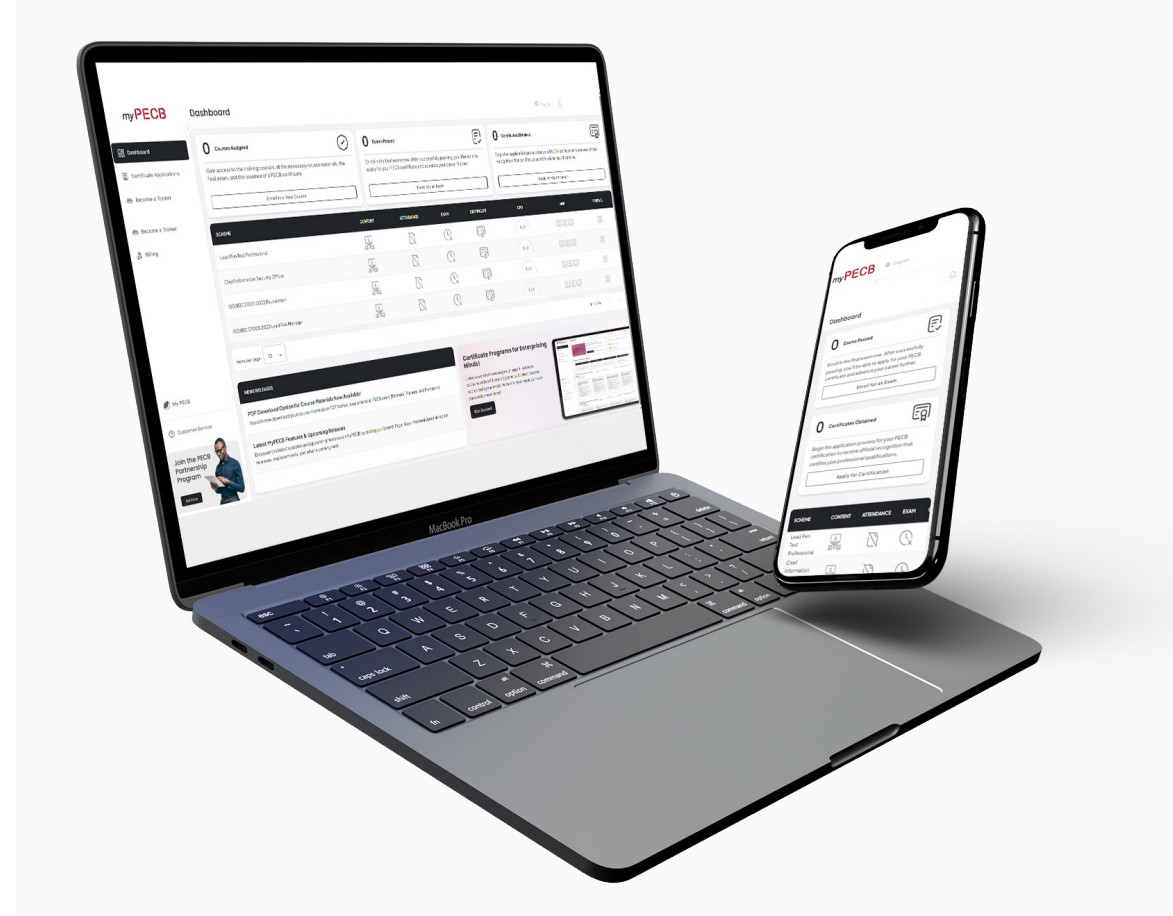
How does the ISO 37001 Foundation eLearning experience look like?

Domain 4: The PECB Examination Committee ensures that the exam questions are adequate and based on professional practice.
